Following 18 years as a civil litigator and 25 years as a judge, Justice Smith brings a wealth of knowledge and experience to his role as a neutral at Judicate West. Justice Smith's distinguished legal career spans more than four decades. During his more than 10 years on the California Fifth District Court of Appeal, he published approximately 30 published opinions and handled complex matters involving antitrust, employment, real estate, insurance bad faith, and medical malpractice. Prior to his appellate appointment, he served on the Fresno County Superior Court for 14 years, where he held a variety of leadership roles, including Presiding Judge and Supervising Judge of the Unlimited Civil Division. Over the course of his judicial tenure, he presided over thousands of cases across every area of law. His career began in public service as a trial deputy with the Fresno County District Attorney's Office, followed by 12 years in private practice handling a broad spectrum of civil litigation. Justice Smith approaches every dispute with the goal of guiding parties toward a fair and thoughtful resolution. He sees his role as a neutral not just as a facilitator of settlement, but as a steward of meaningful negotiation. His deep understanding of the litigation and appellate processes, combined with his calm judicial temperament and unwavering preparation, make him particularly well suited for mediation, arbitration, and appellate neutral evaluations. Justice Smith is widely regarded in the legal community for his integrity, intelligence, and dedication.
