In the final four years of his judicial service, Judge Hurwitz was assigned to Unlimited Civil and then the Complex Civil Litigation Panel, where he managed a diverse docket of sophisticated civil cases including mass torts, wage and hour class actions, Private Attorneys General Act (PAGA) claims, business and commercial disputes, and other high-stakes matters. His ability to efficiently and equitably handle these large, multifaceted cases earned him the respect of practitioners across the legal spectrum. Prior to taking the bench, he built a successful practice for 25 years as a civil litigator, focused on construction defect and personal injury cases. Judge Hurwitz is known for his commitment to helping parties resolve disputes. His philosophy from the bench extends to the private sector, believing that all litigants must have a chance to be heard, be treated fairly and with respect, and be told the truth about their case.
