

Hon. William V. Gallo, Ret.



Judge Gallo joined Judicate West following a distinguished legal career spanning over three decades. He was appointed to the U.S. District Court for the Southern District of California in 2009 and was the Presiding Magistrate Judge from 2020-2022. During his 14 years on the bench, his duties primarily pertained to resolving civil lawsuits and any discovery disputes that arose during litigation. Having presided over more than 2500 settlement discussions, he oversaw a wide array of matters including but not limited to employment, intellectual property, Lemon Law, ADA, FDCPA, FTCA, class actions, and personal injury, Prior to his appointment, Judge Gallo served as a prosecutor at the state and federal levels for a combined 23 years, including 18 years as an Assistant U.S. Attorney for the U.S. Attorney's Office for the Southern District of California in San Diego. He tried approximately 200 jury and bench trials as a criminal trial attorney. Regarding his approach to dispute resolution,

Judge Gallo stated, "I've learned that the case before me is the most important matter in the lives of the parties, regardless of the amount of money possibly at stake. Consequently, it has been my guiding principle to always keep that in mind when I engage with the parties and to treat every one of them with respect and dignity. A component of that is to provide
